While customization can also be done directly on the device, the Editor allows users to adjust vocabulary settings even when the hardware device is unavailable. It serves as a support tool for modifying a client's vocabulary without interrupting their use of the device. ChatEditor is not intended to function as a speech-generating device and is compatible with NovaChat product line, TouchChat and Dialogue iOS applications.
